## CRESTLINE DORA RULES

*Enjoying the DORA safely & appropriately is very important, so there are a few rules to follow.*

1. You must present your valid state or federal ID to a participating DORA vendor, and be at least 21 years of age or older.
2. You may purchase alcoholic beverages from a participating establishment or event vendor. No outside alcoholic beverages are permitted in the DORA.
3. Any alcoholic beverages being consumed in public areas within the DORA boundaries must be in an approved DORA single use cup.
4. You may purchase up to two beverages at a time.
5. You cannot carry a DORA beverage into any other DORA beverage selling business. You may carry your beverage into any non-alcohol serving business at the sole discretion of that business. A sign will be posted on businesses
6. DORA beverages may only be consumed during the DORA approved hours of operation. Crestline DORA hours are Thursday from 5pm to 10pm, Friday from 5pm to 11pm, and Saturday from 12pm to 11pm. DORA beverages may not be consumed outside these hours.

### What is a DORA

Participating Crestline DORA Vendors can sell DORA cups for purchase, allowing you to explore and enjoy the Crestline downtown while sipping beer, wine, or liquor.

### For Establishments:

Participation in the DORA is optional. If you participate: You have all of the same liabilities and responsibilities that you normally would have. Control, rights, and responsibility of your establishment remains intact. If you choose not to have alcohol brought into your business, you may post a sign stating that. This is no different than a sign prohibiting food and drink or proper attire. Specially marked cups must be used; a standard plastic cup, not to exceed 16 oz. Printed stickers (no less than 1" x 1.75") must be placed on the cup with the name of your establishment.

### For Visitors:

Participation in the DORA is optional for liquor establishments so do not expect that every establishment will be selling DORA alcohol. Merchants maintain the same control, rights, and responsibility of their establishment. They may choose not to have alcohol brought into their business. All visitors are required to abide by the merchant's policy.

### Exploring the Crestline DORA
